5 SCAMS TO LOOK OUT FOR IN 2024

- 1. Fake Payment Notifications:** Watch out for payment notifications from text or email. Clicking the link in the notification can lead to phishing websites that steal your login credentials.
- 2. AI-Enhanced Scams:** Scammers are now using AI to make deepfakes that look and sound like real people, like celebrities, CEOs, or even family members, to trick victims into giving them personal information or money.
- 3. Government Account Takeover Scams:** This has been around for some time, but scammers will pretend to be from government agencies like the IRS or local law enforcement, threatening legal action or demanding immediate payment for fabricated debts. These scams often involve urgency and scare tactics.
- 4. QR Code Scams:** QR codes are becoming increasingly popular, but people with ill intent can create fake QR codes that lead to phishing websites or downloading malware onto your device. Double-check the link for misspellings before clicking on it.
- 5. Job Listing Scams:** If you see a job listing that seems too good to be true, it probably is. Red flags to look out for are requiring upfront fees or personal information before an interview. Legitimate companies will not ask for financial information or payment during the application process.
